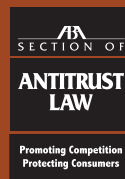

Earlier this year, the U.S. antitrust agencies revised the Horizontal Merger Guidelines, opening discussion within the antitrust bar about whether the changes – many grounded largely in economic theory – herald a significant change in merger enforcement. This program will focus on how and why the guidelines were revised, including whether the changes are simply memorializing existing practice, and what merging parties can expect going forward. The program also will consider the agencies' recent focus on consummated transactions, and whether the new guidelines will affect these actions as well.

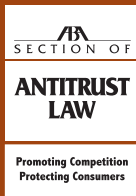
